**One Year Limited Warranty**

Nantucket BeadBoard Co., Inc. (“NBC”) warrants to the structure owner that Nantucket®BeadBoard Panel and/or Strip products will be free from manufacturing defect for a period of One (1) year from the date of original purchase. NBC also warrants that the factory applied prime coat will not blister or peel under normal conditions of use for a period of One (1) year from date of manufacture. This warranty does not extend to non-factory applied finishes on Nantucket®BeadBoard MDF and/or MRI primed or unprimed Nantucket ®BeadBoard panels and/or strips. This Limited Warranty applies and is effective only if Nantucket®BeadBoard MDF and/or MRI panels and/or strips are subject to normal conditions of use, stored, handled, applied, installed, finished, and periodically maintained in accordance with standard building practices and NBC instructions.

THIS LIMITED WARRANTY SHALL BE VOID AND OF NO EFFECT, AND NBC SHALL HAVE NO LIABILITY FOR FAILED PRODUCT, IF SUCH FAILED PRODUCT IS NOT PROPERLY INSTALLED, IS USED FOR APPLICATIONS FOR WHICH IT IS NOT INTENDED FOR USE AND/OR IS USED IN OTHER THAN NORMAL CONDITIONS OF USE OR IS OTHERWISE MODIFIED OR ALTERED.

If NBC determines that there is prime coat failure covered by this Limited Warranty, NBC will refund to the owner the reasonable cost of replacement not to exceed the purchaser's original purchase price of the affected product.

NBC also warrants that the factory applied prime coat will not blister or peel under normal conditions of use and exposure for a period of Five (5) years from date of manufacture. This warranty does not extend to non-factory applied finishes on Nantucket®BeadBoard MRX primed or unprimed Nantucket®Beadboard panels and/or strips. This Limited Warranty applies and is effective only if Nantucket®BeadBoard MRX panels and/or strips are subject to normal conditions of use, stored, handled, applied, installed, finished, and periodically maintained in accordance with standard building practices and NBC instructions.
